

RESOLUTION #12142020-13

A RESOLUTION OF THE MAYOR AND BOARD OF CITY COMMISSIONERS OF THE CITY OF WAURIKA, JEFFERSON COUNTY, STATE OF OKLAHOMA, SCHEDULING REGULAR MEETING DATES FOR THE CALENDAR YEAR 2021; PROVIDING WRITTEN NOTICE TO THE WAURIKA CITY CLERK OF THE REGULARLY SCHEDULED MEETING DATES OF THE PUBLIC BODIES OF THE CITY OF WAURIKA; AND DECLARING AN EMERGENCY.

WHEREAS, pursuant to 25 O.S. § 311(A)(1), all public bodies of the City of Waurika shall give notice to the Waurika City Clerk, in writing by December 15 of each calendar year, of the schedule showing the date, time and place of the regularly scheduled meetings of said public bodies for the following calendar year.

WHEREAS, on December 14, 2020 the Waurika Board of City Commissioners voted to approve a meeting schedule for calendar year 2021, wherein regular meeting dates for all public bodies of the City of Waurika were scheduled.

WHEREAS 25 O.S. § 311(A)(8) provides that if any change is to be made of the date, time, or place of regularly scheduled meetings of public bodies, then notice in writing shall be given to the municipal clerk not less than ten (10) days prior to the implementation of any such change.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND BOARD OF CITY COMMISSIONERS OF THE CITY OF WAURIKA, JEFFERSON COUNTY, STATE OF OKLAHOMA:

That regularly scheduled meetings of the Board of City Commissioners, and all other public bodies of the City of Waurika, shall be held as designated in the Meeting Schedule for Calendar Year 2021, attached as Exhibit "A" hereto, which shall be incorporated as if fully written out herein, unless specifically scheduled on another date in the manner required by state law in accordance with 25 O.S. § 311(A)(8).

BE IT FURTHER RESOLVED that to preserve the health, safety and peace of the citizens of the City of Waurika, an emergency hereby is declared to exist, by reason whereof, this Resolution shall be immediately effective upon its adoption.
