

**RESOLUTION 06142021-09**

**A RESOLUTION OF THE MAYOR AND BOARD OF CITY COMMISSIONERS OF THE CITY OF WAURIKA, JEFFERSON COUNTY, STATE OF OKLAHOMA, AMENDING THE OCCUPATIONAL TAX SCHEDULE WHICH RELATES TO COMMERCIAL MEDICAL MARIJUANA ESTABLISHMENTS TO INCREASE THE AMOUNT OF THE OCCUPATIONAL TAX; AND PROVIDING FOR THE RE-ADOPTION OF THE INITIAL APPLICATION FEE AND RENEWAL APPLICATION FEE.**

**WHEREAS**, Ordinances of the City of Waurika, Oklahoma require application fees, renewal application fees, and occupation taxes to cover costs associated with municipal expenses related to permitting, inspection, administration and enforcement of medical marijuana retailers/dispensaries, commercial growers, and processors which are to be set forth by resolution adopted by the Board of City Commissioners; and

**WHEREAS**, the fee and tax amounts were established and adopted by the Mayor and Board of City Commissioners through Resolution \_06082020-07;

**WHEREAS**, it is necessary to increase the medical marijuana commercial establishment occupational taxes to ensure the fee and tax amounts are necessary to cover costs and to ensure that Certificate of Compliance and ordinance requirements are met;

**NOW THEREFORE BE IT RESOLVED** by the Mayor and Board of City Commissioners of the City of Waurika, Oklahoma that it does, by this action, hereby approve the following fee and tax schedule:

**I.**

Medical Marijuana Dispensary	\$50.00	\$50.00	\$2,500.00
Medical Marijuana Processing Facility (including Limited Medical Marijuana Processing/Rolling Facility)	\$50.00	\$50.00	\$2,500.00
Medical Marijuana Commercial Grower (regardless of the number of plants allowed)	\$50.00	\$50.00	\$2,500.00
Medical Marijuana Testing Laboratory	\$50.00	\$50.00	\$2,500.00
Medical Marijuana Research Facility	\$50.00	\$50.00	\$1,000.00
Medical Marijuana Education Facility	\$50.00	\$50.00	\$1,000.00

**II. GENERAL PROVISIONS:**

A. All fees and taxes paid under this resolution shall be non-transferable and non-refundable.

B. In the event professional fees are incurred, such as inspector fees, architect fees, surveyors, engineers, attorney fees, etc., or fees associated with Special Meetings or hearings, then those charges are in addition to the below stated fee schedule.


C. The Certificate of Compliance holder shall pay all fees and charges before receiving the appropriate Certificate of Compliance.

D. All fees shall be paid simultaneous with submitting the application.

E. The fees paid shall include all mailing and publication costs for such application, if any.

This Resolution shall be effective 30 days following passage.
