

WAURIKA PUBLIC WORKS AUTHORITY APPLICATION FOR SERVICE

The undersigned, hereinafter referred to as the "Applicant," hereby applies for one or more of the following services: water, refuse collection, or sewer from the Waurika Public Works Authority, hereinafter referred to as the "Authority." With the execution of this application, the Applicant agrees to the terms of this agreement.

(1) The Applicant will pay forthwith to the Authority the sum of **\$150** as a deposit for utility service payments. Said deposit shall be retained by the Authority until service is disconnected and final bill is paid in full. At the time of the final bill, the deposit will be refunded or applied to the remaining balance of the final bill. (2) The acceptance of the application by the Authority shall constitute an agreement between the Applicant and the Authority, and the contract for utility services shall continue in force from the date service is made available to the applicant, by the Authority, and thereafter until cancelled by either party. (3) The Applicant will purchase from the Authority: water and/or sewer service and refuse collection to be used on the premises described below, and shall pay therefore monthly at rates which shall from time to time be fixed by the resolution of the Board of Trustees of the Authority: provided, however, that the services which the Authority shall furnish to any customer may be limited to such an amount or degree as the Board of Trustees may from time to time determine. The Applicant will pay said bill for services by the **(10th)** of each month or pay such penalties and fees as may be assessed by the Authority. (4) The Authority reserves the right to demand payment for delinquent utility bills of persons living at this service address. Failure to satisfy this demand will result in the termination of services until delinquent bills are paid or a payment schedule is implemented. (5) The Applicant will comply with and be bound by the provisions of the Regulations of the Authority, and all amendments thereto, and such rules and regulations as may from time to time be adopted by the governing body of the Authority. (6) The Applicant hereby agrees to furnish the following information as required by the Authority and certify that all information is true and correct to the best of my knowledge. Any information found to be false or not supplied, hereby breeches this contract and the above said services can be terminated, the option of the Waurika Public Works Authority. (7) The Applicant or Co-Applicant must reside at the service address or be a landlord/owner of the property for services to be connected. **INITIALS**
